Lexington Completes Housing Assessment

At the February Threshold Housing Commission meeting, Summit Design and Engineering shared the results of their comprehensive city-wide housing conditions study for Lexington. Funded by a \$50,000 Community Development Block Grant (CDBG) Planning Grant awarded in 2023, this study aimed to assess the state of residential properties across the city.

Summit's team conducted a windshield survey in late October, evaluating nearly 2,100 residential properties from the public right-of-way. Each...

The [Transportation Alternatives \(TA\) Program](#) is a federal reimbursement transportation grant funding program administered by the Virginia Department of Transportation (VDOT), and provides 80 percent match funding for transportation projects such as pedestrian and bicycle facilities, safe routes to schools, conversion of abandoned railway corridors to trails, and historic transportation facility preservation. Applicants must submit a pre-application by June 2, and the final application by...
