The Honorable Kenneth Cooper Alexander, Ph.D. Mayor
City of Norfolk

Kenneth Cooper Alexander was elected Mayor of the City of Norfolk on May 3, 2016 and re-elected in May 2020. Dr. Alexander is the Chancellor of a network of career community colleges, 14 Aviation Institute of Maintenance campuses across the country and six Centura College and Tidewater Tech locations within Virginia. Dr. Alexander also serves as president of Metropolitan Funeral Services. A native of Norfolk, he began his public service career more than two decades ago.

Dr. Alexander served in the Senate of Virginia from 2012 – 2016 where he was a member of the committees on Commerce and Labor, Finance, Transportation, and Privileges and Elections. Before his election to the Senate, he represented the 89th District in the House of Delegates from 2002 until 2012, serving on the committees of Commerce and Labor, Education, Privileges and Elections, and Rules.

Prior to serving in the General Assembly, Dr. Alexander was a member of the Norfolk Economic Development Authority, City Planning Commission (vice chair), and Human Services Commission. He is a member of the Greater Norfolk Corporation, the Norfolk Chapter of the FBI Citizens Academy Alumni Association, and an alumnus of the Sorensen Institute for Political Leadership.

Dr. Alexander began his community service as president of Berkley's Beacon Light Civic League and Beacon Light Community Development Corporation. Mayor Alexander is proud that his first full-time job was with the City of Norfolk as a Cemetery Manager with the Department of Parks and Recreation from 1989 to 1990.

Alexander graduated from Norfolk's Lake Taylor High School in 1985 and continued his education in Virginia's public institutions earning an associate's degree in Mortuary Science from John Tyler Community College and a Bachelor's degree in Political Science from Old Dominion University. He later served as an instructor at Tidewater Community College after completing a master's degree in diplomacy from Norwich University. In 2019, Alexander earned a Ph.D. in Leadership and Change from Antioch University.

Dr. Alexander has been a guest columnist in many of Virginia's major newspapers, and he is the author of *Persistence:* Evelyn Butts and the African American Quest for Full Citizenship and Self-Determination which was published in May 2021.



The Honorable Douglass G, "Doug" Pons Mayor City of Williamsburg/Hampton Roads Planning District Commission

Douglas Pons is a lifelong Williamsburg resident. He graduated from Lafayette High School and Christopher Newport University with a B.S. in business administration. He is the owner of The Flats of Williamsburg on York Street in Williamsburg and is a member of the Williamsburg Hotel Motel Association.

Doug has served on a variety of City boards and commissions, including the Planning Commission, Williamsburg Economic Development Authority, Regional Issues Committee, and Architectural Review Board.

He was elected to City Council in 2010 and first elected by City Council to serve as mayor in July 2020. He had previously served a two-year term as vice mayor.

Doug lives in the College Terrace neighborhood with his family.



Stephen A. Edwards CEO and Executive Director Virginia Port Authority

Stephen A. Edwards is the CEO and Executive Director of the Virginia Port Authority (VPA). He is responsible for the broad programmatic areas of business and relationship development, infrastructure development, strategic marketing, economic development, finance, security and safety. He directs and manages the operations of Virginia's marine and inland terminal facilities through Virginia International Terminals, LLC, the port's private terminal operating company, including Virginia International Gateway, Newport News Marine Terminal, Norfolk International Terminals. Portsmouth Marine Terminal. Richmond Marine Terminal and the Virginia Inland Port.

He is a globally experienced leader in the maritime industry with extensive operational experience and a proven track record of growing businesses and creating long-term value for customers and stakeholders.

Before joining the VPA in January 2021, Stephen served as President and Chief Executive Officer for TraPac, LLC.and was responsible for the overall performance of the company with focus on safety, service and sustainability. Prior to that, he was the CEO of Global Container Terminals. Previous industry experience includes president and CEO of Ports America Group and president and CEO of P&O Ports North America.

In his capacity as CEO and Executive Director of the VPA, Stephen serves as an ex-officio member of the Virginia Economic Development Partnership (VEDP) board of directors. Mr. Edwards is a director of the Through Transport Mutual Insurance Association Ltd.

Matthew Bolster Senior Strategic Housing Officer Virginia Housing

Matthew Bolster, AICP is Senior Strategic Housing Officer in the Community Outreach division of Virginia Housing, Virginia's housing finance agency. He began his planning career in 1993 in Spotsylvania County, where he worked in land use administration in what was then Virginia's fastest-growing locality. In subsequent positions he transitioned to community development and housing, assisting smaller localities with revitalization projects as a planning consultant for six years with K.W. Poore and Associates, and later serving 11 years as a project manager for the Richmond Redevelopment and Housing Authority.

In the latter position he coordinated neighborhood revitalization activities under Richmond's Neighborhoods in Bloom program, and then managed public housing transformation projects. He has also served as a policy analyst for the Commission on Local Government. As a member of Virginia Housing's Strategic Housing team since 2016, he now uses his experience to connect public and private organizations to the resources available to produce and preserve affordable housing. Matt has a B.A. in history from the College of William and Mary and a master's degree in city and regional planning from the University of North Carolina at Chapel Hill.

Martha Heeter serves as the Executive Director of the Richmond Regional Planning District Commission, known commonly as PlanRVA, where she is responsible for directing the agency's general operations, strategic planning, project development, and program performance. PlanRVA is an intergovernmental agency that facilitates collaboration among the nine local jurisdictions in the Richmond region, which includes the Town of Ashland, the City of Richmond, and the Counties of Charles City, Chesterfield, Goochland, Hanover, Henrico, New Kent, and Powhatan. She is a member of the Board of Directors for the Partnership for Housing Affordability, Grow

Capital Jobs' GO Virginia Regional Council, Thrive Birth to Five early childhood coalition and Virginia Repertory Theater. She is an alumnus of Lead Virginia (class of 2018) and the Richmond Memorial Health Foundation's 2017 Equity + Health Fellowship program.

Having served more than 18 years in the public sector, her career has included local and regional government leadership positions in the Northern Shenandoah Valley and Richmond Regions. Alleyn Harned is the Executive Director of Virginia Clean Cities (VCC), a member of the U.S. Department of Energy-affiliated Clean Cities Coalitions program.

Alleyn joined Clean Cities in 2009, the same year Virginia Clean Cities, Inc., formed a partnership with James Madison University. That partnership allows Clean Cities and the university in Harrisonburg, Va., to work together to leverage resources, support alternative fuel initiatives and pursue opportunities to decrease pollution and reduce dependence on foreign oil.

Prior to be named Executive Director, Alleyn served as the VCC 's Business Development Director. He served as the Virginia representative to the nine-state Southeast Natural Gas Vehicle Corridor Committee, and was coordinator for Virginia's initial 2010 electric vehicle readiness effort. Harned an appointee to Virginia's Energy Commission in 2014 and the State Advisory Board on Air Pollution in 2013. Harned serves as the President of the Transportation Energy Partners Board of Directors and has served twice as the Mid-Atlantic representative to the Clean

Cities Coordinator Council. Harned led coalition through the completion of the 1200 vehicle Southeast Propane Autogas Development Project under the Recovery Act.

Alleyn has worked on transportation and energy related issues in Virginia since 2006. Before joining the VCC staff, Alleyn served as the Assistant Secretary of Commerce and Trade for the Commonwealth of Virginia where he assisted in drafting Virginia's initial Energy Plan, and participated in the Virginia Commission on Climate Change and Governor's Energy Policy Advisory Council. Harned is a graduate of Ohio Wesleyan University, and has his Masters degree in Public Administration from James Madison University with a focus on community economic development.

With Virginia Clean Cities, Harned leads the Virginia Clean Cities coalition's collaborative effort to assist stakeholders and the Commonwealth in programs to improve air quality, and increase American energy security and economic opportunity through the increased use of alternative fuels and vehicles. Operating since 1996, Virginia Clean Cities has successfully managed tens of millions of dollars of federal, state, and stakeholder vehicle and infrastructure programs from offices on the James Madison campus in Harrisonburg VA. Examples of past projects were the nation's largest propane autogas vehicle deployment project, which covered 13 states, the Richmond Electric Vehicle initiative, which facilitated vehicles, and a Virginia DC and Maryland ethanol deployment project which installed the first ethanol stations in the mid-Atlantic region. Alleyn's theory of change involves incremental collaborative team leadership and drafted the nations only successful dual-state station deployment project for the 2015 USDA Biofuels Implementation Partnership.

Grant Sparks, AICP, serves as the Director of Transit Planning for DRPT, providing leadership in the evaluation, development, and execution of a \$4.2 billion portfolio of public transportation, commuter assistance, and congestion management programs throughout the Commonwealth. Mr. Sparks joined DRPT in 2019 and has more than 12 years of experience in grant management, federal compliance, transit service planning, and transit capital planning. He has served as a Project Manager for the International City/County Management Association (ICMA) in Washington D.C. where he managed a multi-million dollar U.S. EPA contract aimed to educate local

governments on redeveloping blighted and potentially contaminated properties.

He has also served as the Manager of Transit Planning for the Greenville Transit Authority in Greenville, South Carolina, and the Director of Transit Planning for the Chatham Area Transit Authority in Savannah, Georgia. In both positions he administered federal and state transit grants and managed service planning activities for the transit agencies. Mr. Sparks received his Bachelor degree in Public Policy and Administration from James Madison University and his Master of City and Regional Planning from Clemson University.



Roosevelt "Ted" Mercer, Jr. CEO and Executive Director Virginia Commercial Space Flight Authority

Roosevelt "Ted" Mercer, Jr., Major General, USAF (Ret.), is the CEO and Executive Director of the Virginia Commercial Space Flight Authority. Since taking office on August 1, 2021, Mr. Mercer has made it the mission of Virginia Space to serve the Commonwealth's economy by providing safe, reliable, and responsive space launch services, ensuring access to space at competitive prices, and maintaining secure facilities for testing of unmanned vehicles for integration into the National Airspace System (NAS).

Virginia Space is a political subdivision of Virginia. It owns and operates the Mid Atlantic Regional Spaceport collocated at NASA Wallops Flight Facility on the Eastern Shore of Virginia. Mr. Mercer is responsible for the expansion and promotion of the commercial and government space industry in the Commonwealth. He directly oversees successful launch to space, industrial and economic development, and scientific and technological research and development.

Under Mr. Mercer's leadership, Virginia Space continues to reach milestones that signify rapid expansion, including successful launches, the development of new facilities, a new launch pad, and outreach activities with domestic and international space industry organizations.

Prior to joining Virginia Space, Mr. Mercer was the director of the Office of NextGen Collaboration and Messaging at the Federal Aviation Administration. He provided high level leadership by managing and building relationships with a broad representation of stakeholders in the aviation community, federal agencies, and international air navigation service providers.

Mr. Mercer oversaw communication and outreach activities, including performance 2 reporting for the Next Generation Air Transportation System (NextGen). His organization supported the governance of the NextGen Executive Board, the NextGen Management Board, the NextGen Executive Weather Panel, and the NextGen Advisory Committee, managed interagency NextGen issues and coordinated the Office of NextGen's international program to support global harmonization.

Prior to joining the FAA in April 2016, Mr. Mercer served as the Vice President and Director for Government Commercial & International Initiatives, Geospatial Systems, a division of ITT Exelis. He was responsible for government and industry partnerships and international initiatives.

Mr. Mercer served in the United States Air Force (USAF) for more than 32 years (retired January 1, 2008), most recently as Director of Plans and Policy for U.S. Strategic Command at Offutt Air Force Base (AFB) Nebraska. He was responsible for the development and implementation of national security policy, military strategy, space and weapons employment concepts and policy, and joint doctrine as it applied to the command and execution of its missions. Mr. Mercer was also responsible for the development of the nation's strategic war plan, strategic support plans for theater combatant commanders, and contingency planning for the Global Strike mission.

Mr. Mercer has held Air Force command eight times from the squadron to the wing level. Some of his many USAF assignments include Commander, 45th Logistics Group, Patrick AFB, FL; Commander 30th Space Wing, Vandenberg

AFB, CA; Commander, 81st Training Wing, Biloxi, MS; Commander 91st Operations Group, Minot, N.D.; Vice Director of Plans, U.S. Space Command, Peterson AFB, Colorado; Deputy Director of Operations, Headquarters Air Force Space Command, Peterson AFB, CO; and Commandant, Joint Forces Staff College, National Defense University, Norfolk, VA.

Entering the USAF in 1975, Mr. Mercer was a distinguished graduate of the University of Puget Sound's ROTC program. His educational credentials include a BA in urban planning from the University of Puget Sound; MS in counseling from the University of Oklahoma; post-graduate Executive Programs at Syracuse University, National Defense University, and Harvard University's John F. Kennedy School of Government; and a concentrated Executive Financial Development Program at the Wharton School of Business.

Mr. Mercer is a member of the Commonwealth of Virginia Governor's Aerospace Advisory Council; Vice Chairman of the board, National Strategic Research Institute for the University of Nebraska; member of the Board of Trustees for the Rochester Institute of Technology, Rochester, NY; a member of the National Association of Governing Boards; the Commercial Space Transportation Advisory Committee; and the National Space Council Users Advisory Group.



Robert A. Crum Jr.
Executive Director
Hampton Roads Planning District Commission

Mr. Crum began his tenure as Executive Director of the HRPDC/HRTPO on July 1, 2015. He has over 38 years of professional community planning experience. In his role with the HRPDC and HRTPO, he is responsible for coordinating cooperation among the region's 17 jurisdictions in areas such as regional consensus building, legislative affairs and transportation, community, environmental, housing, economic and emergency management planning. Examples of current regional initiatives include the Regional Fiber Initiative, Regional Economic Development Sites Inventory, Regional Legislative Agenda, Birthplace of America Trail, and collaborating with HRTAC in the planning, prioritization and coordination of over \$5 Billion of interstate transportation

improvements in the Hampton Roads region.

From 2008 to 2015, Mr. Crum was the Executive Director of the Richmond Regional Planning District Commission and Transportation Planning Organization. His major accomplishments with the RRPDC included:

- Formation of the Capital Region Collaborative, a strategic partnership between the RRPDC and the Greater Richmond Chamber
- Preparation and approval of the community's first regional Economic Development Strategy
- Formation of a regional emergency management planning program
- Regional investments in the Port of Richmond to leverage this facility as an economic development amenity

Prior to his work at the RRPDC, Mr. Crum worked for 20 years at the Centre Region Council of Governments in State College, Pennsylvania, most recently as the Agency's Planning Director. Between 1988 and 2008, he was responsible for coordinating all aspects of the Agency's regional planning program including preparation and maintenance of the regional comprehensive plan and sewage facilities plan, and oversight for the Region's transportation, land use, community facilities, housing, water resources and environmental planning programs. He completed planning and consensus building for a nationally recognized water reuse project and an award winning inter-municipal zoning effort.

Prior to his work in State College, he was Chief of the Planning Division for Indiana County, Pennsylvania where he coordinated County-wide community and solid waste planning activities.

Mr. Crum holds a bachelor's degree from Mansfield University of Pennsylvania in Geography and Regional Planning. He and his wife Patty have been married for over 37 years and have two sons – Bryan and Brandon.

The Southside Network Authority (SNA) is a regional political subdivision of the Commonwealth of Virginia formed by five cities in South Hampton Roads: the Cities of Chesapeake, Norfolk, Portsmouth, Suffolk, and Virginia Beach. The SNA is responsible for creating a fully integrated

regional fiber network that connects employment areas, higher education, research institutions, and municipal facilities through increased broadband access, speed and capacity while driving down average end-user costs and reducing barriers to entry for innovative new companies wishing to invest in the region. This regional broadband network will allow Hampton Roads to continue to develop as a nationally connected 21st century community and international information gateway, providing the region with the necessary infrastructure to support job creation in many emerging industry clusters.

Vice Mayor Rosemary Wilson has held elected office since 1996 — first with the School Board (1996 to 2000, including being vice chairman), then with the City Council (2000 to present). A graduate of Bayside High School and Old Dominion University, Wilson is a realtor with Howard Hanna Real Estate.

Recognized in 2012 by "Lawyers Weekly" as one of the Most Influential Women in Virginia, Wilson was also appointed by Gov. McDonnell to the Fair Housing Board and the Local Government Advisory Board to the Chesapeake Bay. She was honored by "Inside Business" in 2007 with the Women in Business Achievement Award, and by the Virginia Beach Education Association in 1999 with the Friend of Education Award. She is a fellow of the Sorensen Institute for Political Leadership at the University of Virginia and the Civic Leadership Institute at Old Dominion University.

Rosemary has served as president of the Virginia Municipal League and chairman of the League's Human Development and Education Committee, as well as the Federal Advocacy Council. In 2016, she was named Volunteer of the Year from the Virginia Recreation and Park Society and is the co-chair of Cycle for Survival, a nonprofit that raises money for rare cancer research.

She is a City Council liaison to the Atlantic Park Community Development Authority, Beaches and Waterways Advisory Commission, Development Authority, Health Services Advisory Board, Historic Preservation Commission and School Modernization Special Project, and an appointed member of the Community Organization Grant (COG) Review and Allocation Committee, the In-House Pharmacy Exploratory Committee, the Oceana Land Use Conformity Committee and the Southside Network Authority.
